



Crookham Village Parish Neighbourhood Plan Pre-Submission (Regulation 14) Consultation

The Neighbourhood Plan is being produced by a steering group of community representatives and includes the contributions of those visiting drop in sessions and consultations over the last four years, alongside the group's own research and investigation. The draft plan is now ready for the formal public consultation as required by the regulations which will end at noon on 15th March.

While the full Pre-Submission Consultation Draft of the Crookham Village Parish Neighbourhood Plan can be found at plan4crookham.org, we have also included a summary document on our website which highlights all the major elements of the pre-submission plan. It is recommended that you at least read the summary document before completing it. If you have particular areas of interest, the summary document will help highlight where to find these in the full plan which is in the same section of the plan4crookham.org website.

Once the consultation period is closed, the Steering Group and Crookham Village Parish Council will gather together all the comments received and produce an official consultation statement, listing all the views and opinions submitted and setting out how the plan is to be amended as a result.

The revised Neighbourhood Plan will then be submitted formally to Hart District Council as our local planning authority. Once adopted, the Crookham Village Parish Neighbourhood Plan will become a statutory planning document and will be used to guide developments across the Parish until 2032. Crookham Village Parish Council and the Neighbourhood Plan Steering Group thank you for taking the time to contribute your views.
